The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagor forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows

- (I) That this mortgage shall secure the Mortgagee for such further sums as may be advanced beceafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also secure the Mortgagee for any further bans, advances, readvances or credits that may be made hereafter to the Mortgagee by the Mortgagee so long as the total indictedness thus secured does not exceed the original amount shown on the face hereof.
