WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagoe for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgiger, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgager ruly be indebted to the Mortgager at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars 53.00 to the Mortgager in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby an nowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee's heirs, successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina. County of Greenville, City of Greenville, on the western side of McDaniel Avenue, being shown and designated as Lot No. 4 on a plat of the property of Parrish, Gower and Martin, made by Dalton and Neves, Engineers, dated March, 1923, recorded in the RMC Office for Greenville County, S. C., in Plat Book G, page 197 and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corners of Lots Nos. 4 and 5, said iron pin being located 64.6 feet south from the southwestern corner of intersection of McDaniel Avenue and Cleveland Street and running thence with the line of Lot No. 5, N. 80-00 W. 188 feet to an iron pin; thence S. 4-22 W. along the line of Lot No. 6, 85 feet to an iron pin at the joint rear corner of Lots Nos. 3 and 4; thence along the joint line of said lots, S. 85-38 E. 187 feet to an iron pin on the western side of McDaniel Avenue; thence with the western side of McDaniel Avenue, N. 4-22 E. 66.5 feet to an iron pin, the point of beginning.

And it is agreed between the parties hereto that in the event the property embraced by this mortgage is sold or otherwise conveyed by the Mortgagor prior to the time that the lien created hereby is fully satisfied, or if the title to such property shall become vested in any other person or entity in any manner whatsoever other than because of the death of the Mortgagor, then and in such event, the remaining principal balance secured by this mortgage, together with all accrued interest, shall at once become due and payable, at the option of the legal holder hereof.

It is further agreed that if Mack I. Whittle, Jr. shall cease to be an employee of Bankers Trust of South Carolina, N.A., or a subsidiary, for any reason other than death, then and in such event, the remaining principal balance secured by this mortgage, together with all accrued interest, shall at once become due and payable, at the option of the legal holder hereof.



Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner it being the intention of the parties hereto that all fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever,

The Mortgager covenants that is is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all lens and encumbrances except as provided herein. The Mortgager further covenants to warrant and forever defend all as I singular the said premises unto the Mortgagee forever, from an I against the Mortgager and all persons whomsoever lawfully claiming the same or any part thereof.
