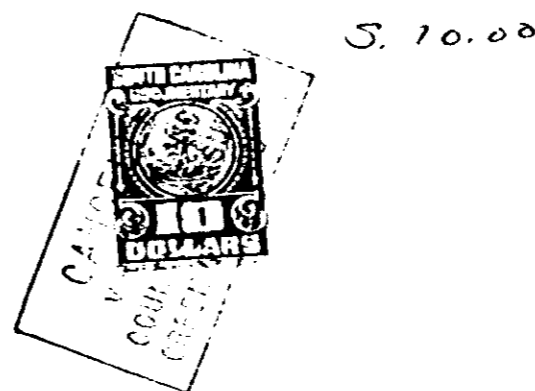
(\$ 25,000.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeastern side of Wood Road and being shown as a 5.89 acre tract on a survey prepared by R. B. Bruce, dated October 2, 1974, entitled "Property of J. F. Miller", said plat being recorded in the RMC Office for Greenville County in Plat Book 5H at Page 43, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at a point in the approximate center of Wood Road, joint corner of the within described property and that now or formerly of H. A. Morris and running thence N.39-59 E. 100 feet to an iron pin; thence N.69-59 E. 180 feet to an iron pin; thence N.15-16 E. 159.4 feet to an iron pin; thence S.71-24 E. 228 feet to an iron pin; thence N.61-21 E. 242.7 feet to an iron pin; thence S.17-51 E. 328.2 feet to an iron pin; thence S.72-51 W. 159.7 feet to an iron pin; thence S.14-48 E. 69.3 feet to an iron pin; thence S.70-12 W. 397.5 feet to an iron pin; thence N.55-26 W. 395.3 feet to an iron pin; thence N.40-15 W. 69.1 feet to the point of beginning.
