MORTGAGE OF REAL ESTATE

ALL that piece, parcel or lot of land, with all buildings and improvements thereon, situate, lying and being on the southwestern side of Theodore Drive, in Greenville County, South Carolina, being shown and designated as Lot No.19 on a Plat of Carolina Heights, Property of Dempsey Construction Co., Inc., made by Dalton and Neves, Engineers, dated August 1964 recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book BBB, page 29, reference to said plat is hereby craved for the metes and bounds thereof.

This mortgage is junior in lien to that mortgage given to Carolina Federal Savings and Loan Association by James H. Lindsey dated May 13, 1966 in the original sum of \$13,000.00 and recorded in the R. M. C. Office for Greenville County, South Carolina in Mortgage Book 1030, page 592.

This mortgage is junior in lien to that mortgage given by George A. Still, Jr., et al to Universal C. I. T. Credit Co., in the original amount of \$6,480.00 dated December 10, 1971 and recorded in Mortgage Book 1216, page 443.

The mortgagor reserves the right to have released from the lien of this mortgage the above described property upon payment to the mortgagee the sum of \$5,000.00.
