NOW, KNOW ALL MEN, that Mortgagor (all, if more than one), to secure payment of a Promissory Note of even date from Mortgagor to the above named Mortgagee in the above Total of Payments and all future and other obligations of Mortgagor to Mortgagee, the Maximum Outstanding at any given time not to exceed said amount stated above, hereby grants, bargains, sells, and releases to Mortgagee, its successors and assigns, the following described real estate together with all present and future improvements thereon situated in South Carolina, County of **Greenville**

ALL that lot (and the city of Greenville, County of Greenville, State of South Carolina, on the north side of Ackley Street, being designated as lot No. 17 on revised plat L.L. Bates recorded in plat book 7 page 47 of the City Office for Greenville, County and having according to said plat the following names and bounds, to-wit:

Beginning at an iron pin on the north side of Ackley Street, the joint front corner of Lots 9 and 10 and running thence with the joint line of said lots N. 23°-30' E. 23.7 feet to an iron pin; thence N. 61-11' E. 60 feet to an iron pin thence S. 28°-17' E. 24.1 feet to an iron pin on the north side of Ackley Street; thence with the north side of said street S. 64.30 W. 60-3 feet to the beginning corner.

This is the same lot conveyed to grantor by LaBrando J. Sample & Marion J. Sample by deed recorded Feb. 26, 1952 in deed vol. 12 page 9 of the City Office for Greenville County, S.C. and is conveyed subject to any recorded restrictions, easements or right of way. TO HAVE AND TO HOLD all and singular the real estate described above unto said Mortgagee, its successors and assigns forever

If Mortgagor shall fully pay according to its terms the indebtedness hereby secured then this mortgage shall become null and void.
