MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

Jesse L. Cooksey (hereinafter referred to as Mortgagor) SEND(S) GREETING:

All that piece, parcel or lot of land located in Greenville County, South Carolina at Lake Lanier, being more particularly described as follows: BEGINNING at a point five (5) feet west of the western edge of East Lake Shore Drive S. 79-45 W. 300 feet to point; thence N. 25-10 W. 68.3 feet to a point; thence N. 56-41 E. 37.5 feet to a point 11 feet west of the western edge of East Lake Shore Drive; thence S. 21-56 E. 48.0 feet to a point six (6) feet west of the western edge of East Lake Shore Drive; thence S. 15-57 E. 33.8 feet to the beginning corner.
