MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of

Sixteen and 66/100 (s 116.66) Dollars each on the first day of each month hereafter, in advance, until the principal surn with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 25 years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortzagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premium's, repairs, or for any other purpose;

NOW KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing of these presents, the receipt whereof is hereby admowledged, has granted, bargained, sold, and released, and by these presents does grant bargain, sell and release unto the Mortgagoe its successors and assigns, the following described real e-state:

All thit certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot No. one (1) on plat of Carver Park Addition made by the Piedmont Engineering Service, February 1953, and recorded in the RMC Office for Greenville County in plat book DD, page 71, and having according to said plat the following courses and distances, to wit:

BEGINNING at an iron pin on the east side of Carter Street, joint front corner of Lots 1 and 2 and running thence along the line of Lot No. 2, S. 89-44 E. 113.2 feet to an iron pin; thence N. 36-54 W. 189.9 feet to an iron pin on Carter Street; thence along Carter Street S. 0-16 W. 152.4 feet to the beginning Corner.
