That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the South side of the Hammett's Bridge Road about two miles Southwest from the City of Greer, designated as lot number Three (3) on plat of B. H. Dillard Estate according to survey and plat thereof by H. S. Brockman, Surveyor, dated April 17, 1941, and having the following metes and bounds according to said plat.
