Whereas, we the said Joe Dawkins and Rosa Lee Dawkins

in and by our certain

note in writing, of even date with these presents, are well and truly indebted to FinanceAmerica Corporation of Anderson, S.C.

in the full and just sum of Six Thousand Six Hundred and no/100 (\$6,600.00)

DOLLARS to be paid in 60 consecutive monthly installments of \$106.00 each; the first installment being due 10-15-75 the remaining installments are due on the same day of each month thereafter

with interest thereon from date APR at the rate of 12.91 per cent, per annum, to be computed and paid annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing

Office of Greenville County, in Plat Book XX page 23 and having, according to said plat, the following metes and bounds, to-wit: BEGINNING at an iron pin on the western side of Lyle Drive at the joint front corner of Lots Nos. 11 and 12 and running thence along the line of Lot No. 11, S. 67-00 W. 190.1 feet to an iron pin, thence S. 23-02 E. 80 feet to an iron pin at the joint rear corner of Lots Nos. 12 and 13; thence along the line of Lot No. 13, N. 67-00 E. 190.1 feet to an iron pin on the western side of Lyle Drive: thence along Lyle Drive, N. 23-02 W. 80 feet to the beginning corner.
