WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

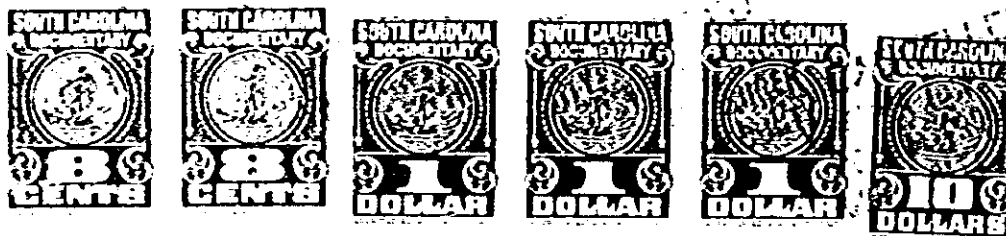

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the Town of Simpsonville, being shown and designated as Lot No. 28 on plat of "The Cedars", dated November 21, 1974, and recorded in Greenville County Plat Book 4X at Page 93, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots Nos. 27 and 28 and continuing along the northern side of Lot No. 27, S. 70-11 W. 90.6 feet to an iron pin; thence continuing along the joint line of Lots Nos. 28 and 29, N. 17-3 W. 132.9 feet to an iron pin at the joint front corner of Lots Nos. 29 and 28; thence continuing along Tollgate Court, N. 71-21 E. 70.0 feet to an iron pin; thence continuing S. 61-25 E. 34.3 feet to an iron pin on the side of Tollgate Road; thence continuing along Tollgate Road, S. 15-9 E. 106.0 feet to the beginning corner.
