(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of-----
Thirty Thousand Eight Hundred and No/100-----DOLLARS

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Kimberly Lane and being known and designated as Lot No. 76 of Drexel Terrace, plat of which is recorded in the RMC Office for Greenville County in Plat Book QQ at Page 177 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the eastern side of Kimberly Lane, joint front corner of Lots 75 and 76 and running thence with the joint line of said Lots, S.85-23 E. 181.2 feet to an iron pin in the line of Lot 71; thence with the line of Lot 71; S.02-37 W. 59.4 feet to an iron pin at the corner of Lots 71 and 70; thence with the line of Lot 70, S.06-23 W. 46.4 feet to an iron pin at the rear corner of Lots 76 and 77; thence with the joint line of said Lots, N.83-23 W. 182.5 feet to an iron pin on the eastern side of Kimberly Lane; thence with said Lane, N.05-08 E. 100 feet to the point of beginning.
