
NOW, KNOW ALL MEN. That the Mentgager, in consideration of the aforesaid debt, and in order to seeme the payment thereof and of any other and further sums for which the Montgager may be indebted to the Mentgager at any time for advances made to or for his account by the Montgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Montgager in hand well and truly paid by the Montgagee at and before the scaling and delivers of these presents, the receipt whereof is hereby acknowledged, has granted, harmand, sold and release unto the Montgagee, its successors and assigns.

TAll that certain piece, parcel or lot of land with all impresements thereon, or breafter constructed thereon, situate lying and being in the State of South Carolina, County of Greenville, on the Western side of Eastwood Drive, and known and designated as Lot No. 54 on Plat entitled OLD MILL ESTATES, SECTION II, prepared by Piedmont Engineers & Architects, dated June 15, 1972, and recorded in Plat Book 4-R, at Page 22, Office of the RMC for Greenville County, S.C. and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Eastwood Drive at the joint front corner of Lots Nos. 53 and 54 and running thence with the common line of said Lots N. 64-50 W. 200.0 feet to an iron pin; thence N. 25-08 E., 110.0 feet to an iron pin; thence S. 64-50 E., 200.0 feet to an iron pin on the western side of Eastwood Drive; thence with Eastwood Drive S. 25-08 N. 110.0 feet to the point of beginning.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgager promises to pay to the mortgagee for the term of the guaranty policy the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgagee may advance it for the mortgagor's amount and collect it as part of the debt secured by the mortgage.

The mortgagors agree to maintain guaranty insurance inforce until the loan balance reaches 75% or less of the original appraisal or sales price, whichever is less, and the mortgagee may apply for mortgage guaranty insurance to comply with the above, through the mortgage guaranty insurance company insuring this loan, and that the mortgagor agrees to pay to the mortgagee, annually, as premium for such insurance 1/4 of 1% of the principal balance then existing.



Together with all and singular the rights, members, hereditaments, and apportenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures, and any other equipment or fixture, now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fix tures, and equipment, other than the usual household foresture, be considered a part of the real estate.
