All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Southeastern side of Fairview Avenue in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 18 of Block K as shown on a plat of Fair Heights, prepared by R. E. Dalton, dated November, 1924, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book F at page 257, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Southeastern side of Fairview Avenue at the joint front corner of Lots Nos. 17 and 18 of Block K and running thence with the line of Lot No. 17 S. 58-40 E. 137.3 feet to an iron pin; thence with the rear line of Lot No. 7 N. 31-20 E. 50 feet to an iron pin at the joint rear corner of Lots Nos. 18 and 19; thence with the line of Lot No. 19 N. 58-40 W. 136.9 feet to an iron pin on the Southeastern side of Fairview Avenue; thence with the Southeastern side of Fairview Avenue S. 31-47 W. 50 feet to the point of beginning.
