NOW, KNOW ALL MEN, that Mortgagor (all, if more than one), to secure payment of a Promissory Note of even date from Mortgagor to the above named Mortgagee in the above Total of Payments and all future and other obligations of Mortgagor to Mortgagee, the Maximum Outstanding at any given time not to exceed said amount stated above, hereby grants, bargains, sells, and releases to Mortgagee, its successors and assigns, the following described real estate together with all present and future improvements thereon situated in South Carolina, County of Greenville. All that piece, parcel or lot of land designated as Lot No. 37 on the plats of property of Lula P. Thurston made by C. C. Jones, C. E., one of the said plats being designated as Section 3 of Lockwood Heights and being recorded in the RNC Office for Greenville County, SC, in Plat Book "X" at page 11 and having according to said plat the following metes and bounds, to-wit;

BEGINNING at a point on Blue Mist Drive joint front corner of Lots Nos. 37 and 38, and running thence N 61-30 E 163.8 feet along line of lot no. 38 to rear corner thereof; thence N 34-15 E 95.5 feet to rear corner of Lot No. 36; thence S 61-31 E 154.1 feet along line of Lot No. 36 to front corner on Blue Mist Drive; thence S 28-30 E 95 feet along Blue Mist Drive to the point of BEGINNING.

If Mortgagor fails to make any of the above mentioned payments or fails to maintain satisfactory insurance, Mortgagee may, but is not obligated to, make such payments or effect insurance in Mortgagee's own name, and such payments and expenditures for insurance shall bear interest at the highest lawful rate if not prohibited by law, shall be a lien hereunder on the above described real estate, and may be enforced and collected in the same manner as the other debt hereby secured.

Upon any default, all obligations of Mortgagor to Mortgagee shall become due, at the option of Mortgagee, without notice or demand.

Mortgagor agrees in case of foreclosure of this mortgage to pay a reasonable attorney's fee as determined by the court in which suit is filed and any court costs which shall be secured by this mortgage and included in judgment of foreclosure.
