NORTH CAROLINA NATIONAL BANK, a corporation organized and existing under the laws of the United States whose address is Charlotte, North Carolina, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Thirty-nine Thousand, Four Hundred and No/100 Dollars (\$ 39,400.00), with interest from date at the rate of eight per centum (8 %) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co. in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Two Hundred Eighty-nine and 20/100 Dollars (\$ 289.20), commencing on the first day of April, 1976, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of March, 2006.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville, State of South Carolina;

All that certain piece, parcel or lot of land, located in the County of Greenville, State of South Carolina, and being known as Lot 169 of Chesterfield Estates, Section I, according to a plat recorded in the R.M.C. Office for Greenville County in Plat Book 5-D at Page 51, and being more particularly described according to a plat entitled "Property of Tommy R. Feagin and Andrea F. Feagin" by R. E. Blackmore, R.L.S., said plat being dated February 6, 1976.
