BEGINNING at an iron pin on the southeastern side of Milford Lane at the joint corner of Lots Nos. 113 and 114, said iron pin being located 471.2 feet more or less from the intersection of Milford Lane with Old Farm Lane and running thence with the southeastern side of Milford Lane, N. 50-55 E. 57.0 feet to an iron pin; thence continuing with said side of Milford Lane, N. 55-31 E., 38.0 feet to an iron pin; thence with the curve of the intersection of Milford Lane with a service lane the chord of which is S. 71-11 E., 15.6 feet to an iron pin; thence with the western side of the service lane, S. 17-13 E., 123.5 feet to an iron pin; thence S. 37-36 W., 36.6 feet to an iron pin; thence S. 51-37 W., 23.0 feet to an iron pin at the joint corner of Lots Nos. 113 and 114; thence with the common line of said lots, N. 39-6 W., 139.7 feet on the southeastern side of Milford Lane, the point of **BEGINNING**.

TOGETHER with all and singular the Rights, Members, Hereditaments, and Appurtenances, to the said Premises belonging, or in anywise incident or appertaining.
