"ALL that certain piece, percel or lot of land, with all improvements thereon, or bereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeast side of S.C. Highway 276, shown as and known as a 4.44 acre tract of land identified on plat of property of Ralph M. Horne and Sam T. Staggs near Travelers Rest, S.C., dated May 14, 1976, by C. O. Riddle, Reg. Ls. 1347, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the C & G R.R. right of way (abandoned) and proceeding N. 26-53 W. along the northeast side of S. C.
