

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, being know and designated as Lot Mo. 103, Section 2, of SUBDIVISON FOR VICTOR MONACHAM MILLS, GREENVILLE, SCUTH CAROLINA, prepared by PICKELL, and PICKELL, Engineers, dated December 20, 1948, recorded in the PMC Office for Greenville County, S.C. in Plat Book S, Pages 179-181, reference to paid plat being craved for a netes and bounds description thereof.

This conveyance is made subject to all restrictions, essenents and rights of way which may affect the property hereinabove described.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
