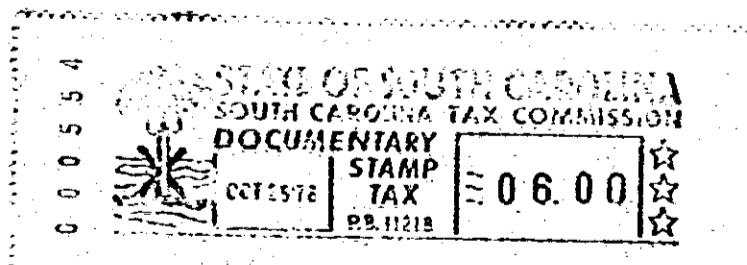

BEGINNING at an iron pin at the joint front corner of Lots 15 and 16, on the northern side of Arthur Avenue, and running thence with the lines of Lots 15 and 16, N. 44-33 W. 44.3 feet to an iron pin; thence with the line of Lot 14, N. 37-32 E. 106.7 feet to an iron pin; thence S. 48-23 E. 127.2 feet to a stake on Arthur Avenue; thence with Arthur Avenue along a curved line, as follows: N. 89-28 W. 35 feet; thence S. 78-24 W. 50 feet; thence S. 64-4 W. 50 feet to the beginning corner.
