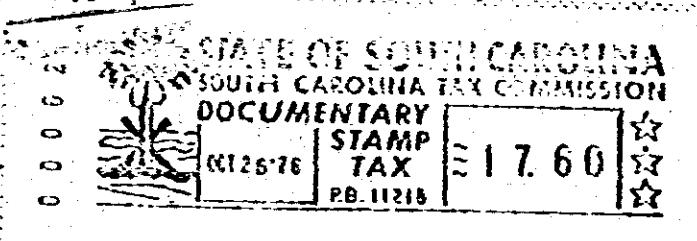
All that certain piece, parcel or lot of land, with all improvements thereon, hereafter constructed thereon, and lying and being in the State of South Carolina, County of Greenville;

ALL that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the northeasterly side of Sylvan Way in the City of Greenville, South Carolina, being designated in the R.M.C. Office for Greenville County, South Carolina, in Plat Book H, Pages 133 and 134, and having according to said Plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly side of Sylvan Way, joint front corner of Lots 84 and 85, and running thence along the common line of said Lots, N. 45-20 E. 232.7 feet to an iron pin on the southwesterly side of a 10 foot easement; thence along said easement S. 54-40 E. 76.2 feet to an iron pin, joint rear corner of Lots 81 and 82; thence along the common line of said Lots, S. 45-20 W. 255.4 feet to an iron pin on the northeasterly side of Sylvan Way; thence along said Sylvan Way, N. 37-35 W. 75.6 feet to an iron pin, the point of beginning.

This conveyance is subject to all restrictions, zoning ordinances, easements and rights of way of record affecting the above described property.
