All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 106 as shown on Map No. 3 of a subdivision known as Foxcroft, Section No. 1, which plat is recorded in the RMC Office for Greenville County, S. C., in Plat Book 4-F, Page 4, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Hunting Hollow Road, the joint front corner of Lots 105 and 106, and running thence along the joint line of said Lots, S. 37-51 W., 207.7 feet to a point in a branch, the joint rear corner of said Lots; thence up the meanders of said branch as the line, a traverse line being N. 26-20 W., 112.6 feet to a point in said branch at the joint corner of Map No. 2 (Lot No. 107); thence N. 18-32 E., 150 feet to an iron pin on the southwestern side of Hunting Hollow Road; thence along the southwestern side of Hunting Hollow Road, following the curvature thereof, the chord being S. 67-09 E., 50 feet to an iron pin; thence continuing along the southwestern side of Hunting Hollow Road, following the curvature thereof, the chord being S. 57-09 E., 50 feet to an iron pin; thence continuing along the southwestern side of Hunting Hollow Road, S. 52-09 E., 52.7 feet to the beginning corner.
