WHEREAS, H. D. AUSTON AND BESSIE L. AUSTON

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

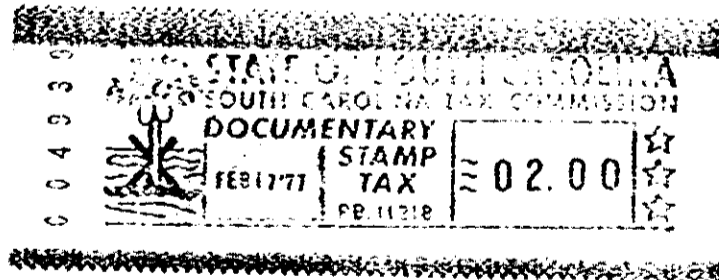
"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the East side of Bayou Street (formerly Batson Alley) and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Bayou Street, 102 feet South of Jenkins Street, at the corner of property of Hardy D. Auston; thence along line of Auston and Parker property in an easterly direction 90 feet to an iron pin; thence in a southerly direction 54 feet to an iron pin at the corner of other property owned by Hardy D. Auston; thence with Auston property in a westerly direction 90 feet to an iron pin on the East side of Bayou Street; thence with the line of said street in a northerly direction 54 feet to point of beginning.

The above property is shown as Lot 7, Block 2, Page 85, Block Book for Greenville County.

Being the identical property conveyed to the mortgagors this day by deed of James C. Shepis of instant date to be recorded herewith.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
