"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Vedado Lane, being shown and designated as Lot No. 48 on a plat of Vardry-Vale, Section 2, made by Campbell and Clarkson Surveyors, Inc., dated March 17, 1969, and recorded in the RMC Office for Greenville County in Plat Book WW, Page 53, reference to which is hereby craved for a metes and bounds description thereof.
