NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Grove Township, and having the following metes and bounds to-wit: BEGINNING at a point in the center of a road, at the center of the Northwestern intersection of said road with a 16 foot road leading to the Roy Allison property and running thence along the Western side of said 16 foot road North 3-30 East 114.8 feet to an iron pin in the line of the Roy Allison property; thence with the line of the Raoy Allison property, North 60-0 West 145 feet to a point in the line of the Elizabeth M. Allison property; thence with the line of the Elizabeth M. Allison property, South 32-10 West 98.6 feet to a point in the center of said mentioned road; thence along the center of said first mentioned road, South 58-45 East 200 feet to the point of beginning.
