TO ALL WHOM THESE PRESENTS MAY CONCERN:

SEND GREETINGS:

WHEREAS, we the said Norman C. & Kathryn C. Eoute hereinafter called Mortgagor, in and by our certain Note or obligation bearing even date herewith, stand indebted, firmly held and bound unto THE CITIZENS AND SOUTHERN NATIONAL BANK OF SOUTH CAROLINA, hereinafter called Mortgagee, in the full and just principal sum of Two thousand five hundred five and 04/100 Dollars (\$2,505.04), with interest thereon payable in advance from date hereof at the rate of 9.99 % per annum; the principal of said note together with interest being due and payable in (30) thirty

monthly installments as follows:
(Monthly, Quarterly, Semiannual or Annual)
Beginning on (last day of) June, 1977, and on the same day of each successive period thereafter, the sum of ninety seven and 63/100 Dollars (\$97.63) and the balance of said principal sum due and payable on the day of , 19 .

The aforesaid payments are to be applied first to interest at the rate stipulated above and the balance on account of unpaid principal. Provided, that upon the sale, assignment, transfer or assumption of this mortgage to or by a third party without the written consent of the Bank, the entire unpaid balance of this note secured by this mortgage, with accrued interest, shall become due and payable in full or may, at the Bank's option, be continued on such terms, conditions, and rates of interest as may be acceptable to the Bank.

Said note provides that past due principal and/or interest shall bear interest at the rate of % per annum, or if left blank, at the maximum legal rate in South Carolina, as reference being had to said note will more fully appear; default in any payment of either principal or interest to render the whole debt due at the option of the mortgagee or holder hereof. Forbearance to exercise this right with respect to any failure or breach of the maker shall not constitute a waiver of the right as to any subsequent failure or breach. Both principal and interest are payable in lawful money of the United States of America, at

the office of the Mortgagee in Greenville, South Carolina, or at such other place as the holder hereof may from time to time designate in writing.

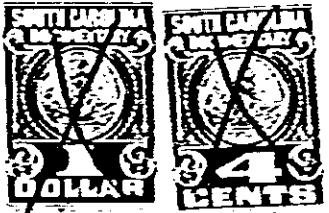

All that lot of land in the county of Greenville, state of South Carolina, known and designated as Lot No. 64 on plat of ISAUQUEENA PARK subdivision recorded in Plat Book P, pages 130-131 of the RMC Office for Greenville County, S. C., said lot having a frontage of 70 feet and a rear width of 70 feet.

This is the same lot conveyed to grantor by Melda H. Hudson, as Trustee, by deed recorded November 5, 1957 in volume 587 page 147 of the RMC Office for Greenville County, and is conveyed subject to restrictions applicable to said subdivision recorded in deed book 314 page 41 and 336 page 370.
