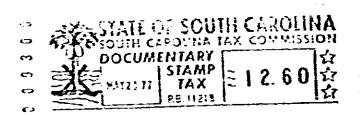

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

ALL that piece, parcel or lot of land located, lying and being in the County of Greenville, State of South Carolina being shown and designated as Lot No. 9 on a plat entitled "Section One, Westminster Village", dated April 15, 1976 prepared by Heaner Engineering Company, Inc., recorded in the R.M.C. Office for Greenville County in Plat Book 5P at Page 40 and having, according to said plat, the following metes and bounds, to-wit:
