MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, BILL A. JORDAN

(hereinafter referred to as Mortgagor) (SEND(S) CREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

FORTY-FIVE THOUSAND AND NO/100 - -

(\$ 45,000.00

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of

FOUR HUNDRED FIFTY-SIX AND 42/100 - (5 456.42) Dollars each on the first day of each month bereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 15 years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the bolder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

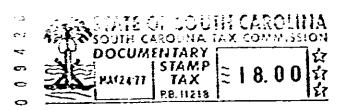
WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW. KNOW ALL MEN. That the Mortzagor, in consideration of said delt and to secure the payment thereof and any further sums which may be advanced by the Mortzagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortzagor in hand well and truly paid by the Mortzagoe at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortzagoe its successors and assigns, the following described real estate:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville in Greenville Township, being known and designated as LOTS NOS. 8 and 9 as shown on plat entitled "Survey for Bill A. Jordan" made by Carolina Surveying Co. dated May 16, 1977 and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin at the corner of Mason Street and Pendleton Street and running thence along Pendleton Street, South 65-51 East 105.7 feet to an iron pin; running thence South 43-45 West 129 feet to an iron pin on Burdette Street; running thence along Burdette Street, North 46-15 West 100 feet to an iron pin on Mason Street; running thence along Mason Street North 43-45 East 93.4 feet to an iron pin on Pendleton Street, the beginning corner.

This being the same property conveyed to the above named Mortgagor by deed of Wade H. Ridgeway which is being recorded simultaneously with this Mortgage.
