MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

LINDA K. BLACK

. (hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagoe) in the full and just sum of

--Twenty-Two Thousand Eight Hundred Dollars -----(\$22,800.00--)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note does not a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of One Hundred

Ninety-One and 34/100ths -----(\$191.34----) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortzagee, or any stipulations set out in this mortzage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose,

NOW. KNOW ALL MEN. That the Mortzazor, in consideration of said delt and to secure the payment thereof and any further sums which may be advanced by the Mortzazoe to the Mortzazoe's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortzazoe in hand well and truly paid by the Mortzazoe at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortzazoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Gantt Township, being known and designated as Lot No. 13 of a subdivision known as Chestnut Hills as shown on plat thereof prepared by R. K. Campbell, recorded in the R.M.C. Office for Greenville County in Plat Book GG, at pages 35 and 65, and having the following metes and bounds, to wit:

BEGINNING at an iron pin on the northern side of Butternut Drive, joint from corner of Lots Nos. 12 and 13, and running thence along the joint line of said lots, N. 7-55 E. 150 feet to an iron pin; thence N. 83-05 W. 70 feet to an iron, joint rear corner of Lots 13 and 14; thence along the joint line of said lots, S. 7-55 W. 150 feet to an iron pin on the northern side of Butternut Drive; thence along the northern side of Butternut Drive, S. 82-05 E. 70 feet to the beginning corner.

This conveyance is made subject to any restrictions, reservations, zoning ordinances or easements that may appear of record, on the recorded plat(s) or on the premises.
