SEVENTY SIX & 81/100 -----) Dollars each on the first day of each month hereafter in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 30 . years after date: and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortzagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and espenses for proceedings; and

WHEREAS, the Mortgazor may hereafter become indebted to the Mortgazee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, issurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortzazor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortzazoe to the Mortzazoe's account, and also in consideration of the sum of Three Dollars (53.00) to the Mortzazoe in hand well and truly paid by the Mortzazoe at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

B. Martin Subdivision, as shown on plat of record in plat book F page 102 and having the following metes and bounds, to-wit:
