

NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the northeastern corner of the intersection of Myron Lane with Crestfield Road, being shown as Lot No. 3 on a plat of the property of Donald E. Baltz, made by C. O. Riddle Surveyor dated January 1955 recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book BB at page 175, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Crestfield Road at the joint front corners of Lots Nos. 2 and 3 and running thence with the common line of said lots, N. 41-01 W., 121.6 feet to an iron pin; thence with the line of Lot No. 4, S. 39-35 W., 89.7 to a point on the northeastern side of Myron Lane; thence with the northeastern side of Myron Lane, S. 29-27 E., 73 feet to a point; thence with the curve of the intersection of Crestfield Road with Myron Lane, the chord of which is S. 80-41 E., 25 feet to a point on Crestfield Road; thence with the northern side of Crestfield Road, N. 60-26 E., 66.9 feet to a point; thence continuing with said side of Crestfield Road, N. 48-59 E., 26.4 feet to the point of BEGINNING.
