NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeastern side of Berryhill Road, being shown and designated as Lot No. 3, Section II, Lake Forest Subdivision, dated March 1954, prepared by Piedmont Engineering Service, recorded in Plat Book EE at Page 71A and being described, according to said plat, more particularly, to-wit:

BEGINNING at an iron pin on the northeastern side of Berryhill Road at the joint front corner of Lots 2 and 3 and running thence along the common line of said lots N. 53-31 E. 281.5 feet to the joint rear corner of said lots; thence S. 52-49 E. 100 feet to an iron pin at the joint rear corner of Lots 3 and 5; thence S. 46-17 W. 164.6 feet to an iron pin at the joint corner of Lots 4 and 5; thence S. 56-14 W. 145 feet to an iron pin on the northwestern side of Berryhill Road at the joint front corner of Lots 3 and 4; thence along the northeastern side of said road N. 37-11 W. 110 feet to an iron pin, the point of beginning.
