(\$ 51,200.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement in writing, the final maturity of which is 29 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

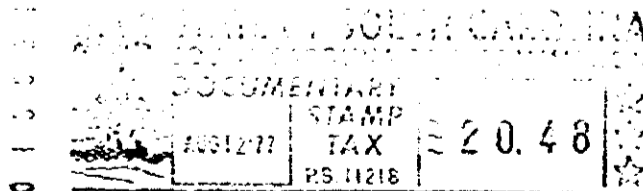

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Mauldin, being known and designated as Lot No. 29 on plat of Forrester Woods, Section 7, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 5-P, at pages 21 and 22, having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Piney Grove Road at the joint front corner of Lots 28 and 29 and running thence with the line of Lot 28 N. 77-54 W. 150 ft. to an iron pin in the line of property designated as Section 2, Forrester Woods at the joint rear corner of Lots 28 and 29; thence with the line of property now or formerly designated as Section 2, Forrester Woods, N. 12-06 E. 100 ft. to an iron pin at the joint rear corner of Lots 29 and 30; thence with the line of Lot 30 S. 77-54 E. 150 ft. to an iron pin on the Western side of Piney Grove Road at the joint front corner of Lots 29 and 30; thence with the Western side of Piney Grove Rd. S. 12-06 W. 100 feet to the point of beginning.

This being the same property conveyed to the mortgagor herein by deed of W. D. Yarborough, dated August 4, 1977, and recorded in the R.M.C. Office for Greenville County, S. C. on August 5, 1977 in Deed Book 1061 at Page 973.
