"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, All that lot of land, with the buildings and improvements thereon, situate on the Northeast side of Blythwood Drive, in the City of Greenville. In Greenville County, South Carolina being shown as lot 32 on a plat of University Circle, made by Piedmont Engineering Service May 1948, recorded in the RMC Office for Greenville County, S.C. in Plat Book "Y" at page 111, and having according to said plat the following metes and bounds to wit:

BEGINNING at an iron on the Northeast side of Blythwood Drive at joint front corner of lots 31 and 32, and running thence with the line of lot 31, North 67-34 E. 124.5 feet to an iron pin; thence N. 24-56 W 60.5 feet to an iron thence with the line of lot 33, S. 71-34 W. 130.8 feet to an iron pin on the Northeast side of Blythwood Drive  $\S$  29-21 E. 70 feet to the beginning corner.


