All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of West Dorchester Boulevard, near the City of Greenville, and being known and designated as Lot 175 according to a plat of the property of Belle Meade as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book "EE" at pages 116 and 117 and having, according to said plat, the following metes and bounds, to-wit:
