ALL that certain piece, parcel or lot of land, with improvements thereon, situate, lying and being in the County of Greenville, State of South Carolina being shown as a 1.14 acre tract on a plat of survey prepared by Charles K. Dunn and Dean C. Edens dated July 26, 1967 and designated as Lot A and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin in the western edge of U. S. Highway 25 and running thence S. 10-15 W. 22 feet to an iron pin; thence S. 1-15 W., 60.4 feet to an iron pin at the joint corner with other property of King; thence with the joint line of other property of King S. 69-57 W., 148.2 feet to an iron pin; thence N. 86-03 W., 252 feet to an iron pin at the corner with other property of King; thence N. 16-30 E., 140.7 feet to an iron pin; thence S. 86-43 E., 358 feet to the beginning corner.

ALSO: ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, near U. S. Highway No. 25, near the interesection of said highway with S. C. Highway 418, and being shown as the western portion of the property on a plat prepared for Richard C. BEGINNING at an iron pin at the joint corner of property of Ansel King and Richard King and running thence S. 16-30 W., 65 feet to an iron pin; thence turning and running N. 75-36 W., 384.4 feet to an iron pin; thence turning and running N. 28-44 E., 142.7 feet to an iron pin; thence turning and running S. 86-43 E., 324 feet to a point; thence turning and running S. 16-30 W., 140.7 feet to an iron pin, point of beginning.
