TO ALL WHOM THESE PRESENTS MAY CONCERN: Harry E. Bryant and Kay S. Bryant

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty Nine Thousand and 00/100-----DOLLARS

(\$ 29,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is thirty years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Town of Mauldin, on the southwestern side of Lanier Lane, and being known and designated as Lot No. 13 on a plat of Cedar Terrace recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book BBB at Page 137, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Lanier Lane at the joint front corner of Lots Nos. 12 and 13 and running thence along said Lanier Lane S. 59-06 E. 110. feet to an iron pin; thence continuing with said Lanier Lane S. 65-34 E. 37.7 feet to an iron pin; thence S. 83-01 W. 46.3 feet to an iron pin; thence S. 47-05 W. 70.6 feet to an iron pin; thence S. 8-04 E. 184.5 feet to an iron pin; thence S. 60-05 W. 62.5 feet to an iron pin; thence N. 30-45 W. 240.9 feet to an iron pin; thence along the joint line of Lots Nos. 12 and 13, N. 42-13 E. 179.2 feet to the point of beginning.
