Jesse R. Timmons and Avinell S. Timmons (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Eighteen Thousand Four Hundred and no/100----- DOLLARS

(\$ 18,400.00-----), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty-five years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lots 60 and 61 on plat of the property recorded in Plat Book II at page 192 and a revised plat of Coleman Heights recorded in Plat Book KK at page 29, prepared by Terrk T. Dill and revised May 24, 1956, and according to said plat, having the following courses and distances:

BEGINNING at an iron pin on the western side of Mill Creek Road at the joint front corner of Lots 59 and 60 and running thence with the common line of said lots and a creek, N. 65-55 W. 150 feet to an iron pin; thence continuing N. 65-55 W. 140 feet to an iron pin at the joint rear corner of Lots 61 and 65; thence running N. 34-10E170 feet to an iron pin at the joint corner of Lots 61, 62 and 64; thence with the common line of Lots 61 and 62, S. 84-05 E. 200 feet to an iron pin at the joint front corner of Lots 61 and 62 on the western side of Mill Creek Road; thence with the western side of Mill Creek Road, S. 5-35 W. 100 feet to an iron pin, thence continuing with said road, S. 0-53 W. 121 feet to the point of beginning.
