MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Boyce E. Revis

(hereinafter referred to as Mortgagor) is well and truly indebted unto James Winkler and Evelyn G. Winkler

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Twenty-Two Thousand and No/100 \_\_\_\_\_ Dollars (\$ 22,000.00 ) due and payable \$161.43 on the 26th day of August, 1978 and \$161.43 on each and every month thereafter until paid in full on the 26th day of July, 2008

with interest thereon from date hereof at the rate of eight per centum per annum, to be paid: monthly

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, being known and designated as Lot No. 20 as shown on Final Plat of Ogden Acres, prepared by Carolina Engineering & Surveying Co., dated September 25, 1964, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book BBB at page 27, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northwestern side of Ogden Drive at the joint front corner of Lots Nos. 19 and 20; and running thence with the line of Lot No. 19 N. 33-40 W. 131.3 feet to an iron pin in the subdivision property line; thence with the subdivision property line N. 56-10 E. 120 feet to an iron pin at the joint rear corner of Lots Nos. 20 and 21; thence with the line of Lot No. 21 S. 33-40 E. 131.3 feet to an iron pin on the Northwestern side of Ogden Drive; thence with the Northwestern side of Ogden Drive S. 56-10 W. 120 feet to the point of beginning

THIS being the same property conveyed to the Mortgagor herein by deed of James Winkler and Evelyn G. Winkler, of even date, to be recorded herewith.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
