MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, We, Arlie D. Tinsley and Jane B. Tinsley,

hereinafter referred to as Mortgagor) is well and truly indebted unto Vance R. Bettis and John Randolph Bettis

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Twenty Thousand and NO/100**

Dollars \$20,000.00 due and payable

one (1) year from date

with interest thereon from date at the rate of 8 per centum per annum, to be paid: annually

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, and being on the Southern side of James Street and being shown on a recent plat dated July, 1978, by Charles F. Webb, Surveyor, and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of James Street at a point 294 feet, more or less, from the intersection of Buncombe Street and James Street and running thence along the line of James Street, N. 62-32 E. 96.40 feet to an iron pin; thence S. 27-31 E. 269.6 feet to an iron pin; thence S. 66-15 W. 39.39 feet to an iron pin; thence N. 27-46 W. 33.79 feet to an iron pin; thence S. 81-00 W. 86.06 feet to an iron pin; thence N. 32-30 W. 44.92 feet to an iron pin; thence N. 60-39 E. 31-18 feet to an iron pin; thence N. 28-27 W. 160.23 feet to an iron pin on the Southern side of James Street at the BEGINNING corner.
