C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Fifty nine thousand four hundred & 00/100-----

DOLLARS (\$ 59,400.00), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 123, on a plat of HOLLY TREE PLANTATION, PHASE II, Sec. III--B, made by Piedmont Engineers and Architects, Surveyors, dated April 20, 1978, recorded in the RMC Office for Greenville County, S.C., in Plat Book 6-H, page 41, and having according to said plat the following metes and bounds description.

BEGINNING at an iron pin on the northwestern side of Holly Park Lane at the joint front corner of Lot 122 and Lot 123 and running thence with Lot 122, N. 52-33 W., 144 feet to an iron pin at the joint rear corner of Lot 122 and Lot 123; thence with Lot 129 and Lot 128, N. 25-10 E., 121.9 feet to an iron pin at the joint rear corner of Lot 123 and Lot 124; thence with Lot 124, S. 52-50 E., 170 feet to an iron pin on Holly Park Lane; thence with said lane S.37-27 W., 120 feet to the point of beginning.
