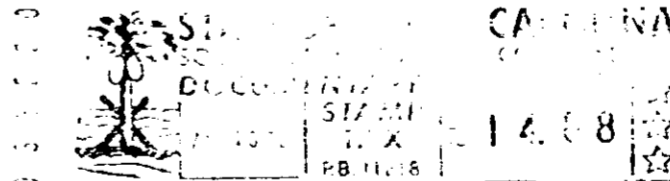

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 93 on the northern side of Mimosa Drive on plat of Heritage Hills recorded in the RMC Office for Greenville County in Plat Book YY, Page 187, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint corner of Lots 93 and 94 on Mimosa Drive and running thence along the common boundary of said lots N 4-06 W 161.3 feet to an iron pin; turning and running thence with the common boundary of Lots 93, 88 and 89, N 83-15 E 130 feet to an iron pin; turning and running thence with the common boundary of Lots 91, 92 and 93, S 4-25 W 200.1 feet to an iron pin; turning and running thence along the common boundary of Lot 93 with Mimosa Drive S 77-10 E 105 feet to an iron pin, the point of beginning.
