TO ALL WHOM THESE PRESENTS MAY CONCERN:

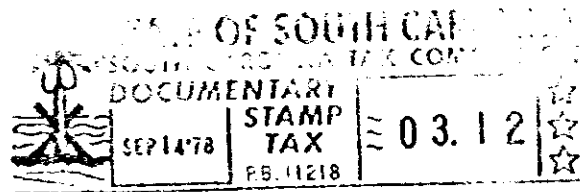

ALL that lot of land in the county of Greenville, State of South Carolina, known and designated as Lot No. 25 as shown on plat of Oxford Estates subdivision, recorded in the RMC Office for Greenville County in Plat Book W, Page 158, said lot having a frontage of 82 feet on the southwest side of Caroline Street, a parallel depth of 150 feet, and a rear width of 82 feet.
