# MORTGAGE

THIS MORTGAGE is made this 27th day of October 19 78, between the Mortgagor, Phillips L. Scoville and Frances G. Scoville (herein "Borrower"), and the Mortgagee, FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of SOUTH CAROLINA, whose address is 101 EAST WASHINGTON STREET, GREENVILLE, SOUTH CAROLINA (herein "Lender").

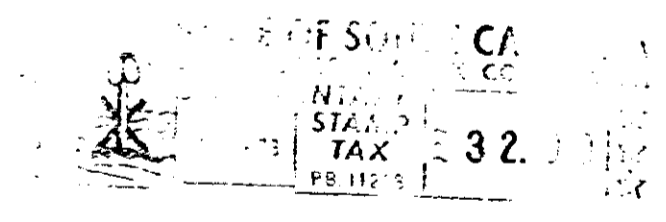
WHEREAS, Borrower is indebted to Lender in the principal sum of Eighty thousand and no/100ths Dollars, which indebtedness is evidenced by Borrower's note dated October 27, 1978 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on April 1, 2008,

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

All that lot of land situate on the southerly side of Coventry Road in the County of Greenville, State of South Carolina, being shown as Lot No. 11 on a plat of Stratton Place Subdivision dated July 10, 1972 prepared by Piedmont Engineers and Architects recorded in Plat Book 4-R at Page 36 in the RMC Office for Greenville County and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southerly side of Coventry Road at the joint front corner of Lot 11 and Lot 12 and running thence with Coventry Road, S 65-00 E 45 feet to an iron pin; thence still with said Road, S 56-09 E 35 feet to an iron pin at the joint front corner of Lot 10 and Lot 11; thence with Lot 10, S 33-59 W 169.9 feet to an iron pin at the joint rear corner of Lot 10 and Lot 11; thence N 56-08 W 195 feet to an iron pin at the joint rear corner of Lot 11 and Lot 12; thence with Lot 12, N 69-15 E 199.7 feet to an iron pin, the point of beginning.

To HAVE AND TO HOLD unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are herein referred to as the "Property".

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
