

**MORTGAGE OF REAL ESTATE**

TO ALL WHOM THESE PRESENTS MAY CONCERN:

This Mortgage made on or as of the 6th day of December 1978 between Edna Alice White & Priscilla Adair (hereinafter called "Mortgagor"), residing at 22-Pickney Street in the City of Greenville, County of Greenville, the State of South Carolina, and the United States of America, (hereinafter called "Mortgagee"), acting by and through the Department of Housing and Urban Development, having a Regional Office at Room 645 Peachtree-Seventh Building in the City of Atlanta, County of Fulton, and State of Georgia, Seventeen thousand nine

WITNESSETH, that to secure the payment of an indebtedness in the principal amount of hundred & no/100's Dollars (\$ 17,900.00 ), with interest thereon, which shall be payable in accordance with a certain note, bond or other obligation (which note, bond or obligation is hereinafter called "Note"), bearing even date herewith, a true and correct copy of which, exclusive of the signature of the Mortgagor, marked "Schedule A", is annexed hereto and made a part hereof, and all other indebtedness which the Mortgagor is obligated to pay to the Mortgagee pursuant to the provisions of the Note and this Mortgage, the within written Mortgage is given.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the said Mortgagee, its successors and assigns, the following described real estate, to wit:

ALL that piece, parcel or lot of land lying and being in the City of Greenville, County and State aforesaid, being known and designated as Lot No. 15, on a plat of the "Homeplace of W. P. McBee, deceased", made by J. N. Southern, Surveyor, dated May 15, 1902, and recorded in the RMC Office in Plat Book A page 83, and having the following metes and bounds to wit:

BEGINNING at an iron pin on the northeastern side of Pickney Street at the joint front corners of Lots 13 and 15, and running thence along the common line of said lots N. 39-50 E. 255 feet, more or less, to a point; thence along the line of property now or formerly owned by Williams, N. 33-50 W. 67.5 feet, more or less, to a point at the joint rear corner of Lots 15 and 17; thence along the common line of said lots S. 39-50 W. 274 feet, more or less, to a point on Pickney Street; thence along the northeastern side of Pickney Street S. 50-50 E. 65 feet, more or less, to an iron pin, the beginning corner.

THIS property is known and designated as Block Book 19-1-19.

THIS is the same property conveyed to Edna Alice White and Priscilla Adair from William G. Ehlen and is recorded in the RMC Office in Deed Volume 1080 page 67 on May 30, 1978 at 4:36.

THIS mortgage is junior in lien to a mortgage recorded in REM Volume 1316 page 858 with an assignment to Federal National Mortgage recorded in REM Volume 1318 page 520.

TOGETHER with all appurtenances thereto and all the estate and rights of the Mortgagor in and to such property or in any wise appertaining thereto; all buildings and other structures now or hereafter thereon erected or installed, and all fixtures and articles of personal property now or hereafter attached to, or used in, or in the operation of, any such land, buildings or structures which are necessary to the complete use and occupancy of such buildings or structures for the purposes for which they were or are to be erected or installed, including, but not limited to, all heating, plumbing, bathroom, lighting, cooking, laundry, ventilating, refrigerating, incinerating and air-conditioning equipment and fixtures, and all replacements thereof and additions thereto, whether or not the same are or shall be attached to such land, buildings or structures in any manner;

TOGETHER with any and all awards now or hereafter made for the taking of the property mortgaged hereby, or any part thereof (including any easement), by the exercise of the power of eminent domain, including any award for change of grade of any street or other roadway, which awards are hereby assigned to the Mortgagee and are deemed a part of the property mortgaged hereby, and the Mortgagee is hereby authorized to collect and receive the proceeds of such awards, to give proper receipts and acquittances therefor, and to apply the same toward the payment of indebtedness secured by this Mortgage, notwithstanding the fact that the amount owing thereon may not then be due and payable; and the Mortgagor hereby agrees, upon request, to make, execute and deliver any and all assignments and other instruments sufficient for the purpose of assigning each such award to the Mortgagee, free, clear and discharged of any encumbrances of any kind or nature whatsoever; and

TOGETHER with all right, title and interest of the Mortgagor in and to the land lying in the streets and roads in front of and adjoining the above described land (all the above described land, buildings, other structures, fixtures, articles of personal property, awards and other rights and interests being hereinafter collectively called the "mortgaged property").

TO HAVE AND TO HOLD the mortgaged property and every part thereof unto the Mortgagee, its successors and assigns forever for the purposes and uses herein set forth.

AND the Mortgagor further covenants and agrees with the Mortgagee, as follows:
