TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, I, 11154 Fisher

(hereinafter referred to as Mortgagor) is well and truly indebted unto Deutsche Bank and National Credit Union

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Five Thousand Dollars (\$5,000.00)

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Jonesville Road, being more particularly described as a part of Lot 11, Block 11, S.S., dated November 15th, 1970, which lot is recorded in the 113 Office for Greenville County, South Carolina in 1st Book 11, at Page 32, and having, according to said plat the following description, to-wit:

BEGINNING at a well known point in the center of Jonesville Road, which well and city is approximately 2,200 feet from the intersection of Jonesville Road and Scuffletown Road, and running thence North 112.5 feet to an iron pin; thence North 77.5 degrees West 223.6 feet to an iron pin; thence North 77.5 degrees West 223.6 feet to a well and city in the center of Jonesville Road; thence South 77.5 degrees West 223.6 feet to a well and city in the center of Jonesville Road, the center of which is 17th Street.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
