And the said Morigagor does hereby covenant and represent unto the said Morigagee, its successors or assigns, that he is lawfully seized in fee of the property above described, and that the property is free from all encumbrances except a morigage to

Fidelity Federal Savings & Loan Association . recorded August 6 . 19 73.

In the Greenville County Courthouse, in Mortgage Book 1287 at page 16 that he has a good and tawful right to will and convey the same as aforesald; that he will warrant and defend the title to the same forever against the lawful claims and demands of all persons whomevers. And the said Mortgagor does further coverant and agree to pay all taxes due and to become due on the property above described, all assessments for street or other improvements and keep the buildings thereon insured against loss by wind, storm, fire and such other casualty as may be required by Mortgagee, its successors or assigns, in such responsible insurance company or companies as shall be satisfactory to the Mortgagee, its successors or assigns, in an amount satisfactory to said Mortgagee, its successors or assigns, with a mortgagee and subrogation clause satisfactory to the Mortgagee attached to said policy or policies of insurance. And it is covenanted and agreed that d all or any part of the Property or an interest therein is sold or transferred by Mortgagor without Mortgagor's prior written consent, excluding (a) the creation of a hen or encumbrance subordinate to this mortgage. (b) the creation of a purchase money security interest for household appliances. (c) a transfer by devise, descent or by operation of law upon the death of a joint tenant or (d) the grant of any leasehold interest of three years or less not containing an option to purchase, Mortgagoe may at its option, dectare all the sums secured by this mortgage immediately due and payable. Mortgagoe shall have waived such option to accelerate if, prior to the sale or transfer, Mortgagoe and the person to whom the property is to be sold or transferred reach agreement in a criting that the credit of such person is satisfactory to Mortgagoe and that the interest payable on the sums secured by this mortgage shall be at such rate as Mortgagoe shall request, and if the required assumption for is paid. If Mortgagoe has waived the option to accelerate and if Mortgagor's successor in interest has executed a written assumption agreement accepted in writing by Mortgagoe. Mortgagor shall release Mortgagor from all obligations under this Mortgage and Note. If Mortgagoe exercises such option to accelerate. Mortgagoe within which Mortgagor may pay the sums declated due. If Mortgagor fails to pay such sums prior to the expiration of such period. Mortgagoe may, without further notice or demand on Mortgagor, invoke any remedies permitted under this Mortgage.

And it is coveranted and agreed that the said Mortgagor does hereby amign, set over and transfer to the said Mortgagee, its successors or assigns, all of the rents, issues and profits of the said mortgaged premises accruing and falling due from and after the service of summons issued in an action to foreclose this mortgage after default in the conditions thereof. In the event Mortgagee exercises its option to accelerate or in the event the mortgaged premises is abandoned. Mortgagee shall be entitled to have a receiver appointed by a court to enter upon, take possession of and manage the mortgaged premises and to collect the rents, issues and profits of the mortgaged premises, including those past due. All rents collected by the receiver shall be applied first to payment of the costs of management of the mortgaged premises and collection of rents, including, but not limited to, receiver's fees, premiums or receiver's bonds and reasonable attorney's fees, and then to the sums secured by this mortgage.
