- 2. That, together with, and in addition to, the monthly payments of principal and interest payable under the terms of the note secured hereby, he will pay to the Mortgagee, on the first day of each month until the said note is fully paid, the following sums:
 - (ii) An art unit sufficient to provide the holder here if with funds to pay the next northware insurance premium, if this instrument and the note secured hereby are insured or a nonthly charge in lieu of a northware insurance premium; if they are held by the Secretary of Housing and Urban Development, as follows:
 - (I) If and so long as said note of even date and this instrument are insured or are reinsured under the processions of the National II using Act, an amount sufficient to accumulate in the hands of the holder one (I) month prior to its due date the annual northcage insurance premium, in order to provide such holder with funds to pay such premium to the Secretary of If using and Urban Development pursuant to the National Housing Act, as amended, and applicable Regulations thereunder, or
 - (II) If and so long as said note of even date and this instrument are held by the Secretary of Housing and. Urban Development, a nonthly charge iin lieu of a mortgage insurance premium) which shall be in an amount equal to one-twelfth (I-12) of one-half (I) per centum of the average outstanding balance due on the note computed without taking into account delinquencies or prepayments;
 - the A sum equal to the ground rents, if any, next due, plus the premiums that will next become due and payable on policies of fire and other hazard insurance covering the mortgaged property plus taxes and assessments next due on the mortgaged property tall as estimated by the Mortgagee's less all sums already paid therefor divided by the number of months to elapse before one (1) month prior to the date when such ground rents, gremiums, taxes, and assessments will become delinquent, such sums to be held by Mortgagee in trust to pay said ground rents, premiums, taxes, and special assessments; and

If there shall be a default under any of the provisions of this most page reculting in a public sale of the premists covered hereby, or if the property is otherwise acquired after default, the Mortgagee shall apply, at the time of the commencement of such reoccedings, or at the time the property is otherwise acquired, the balance then remaining in the funds accumulated under (b) of paragraph 2 preceding, as a credit against the amount of principal then remaining unpaid under the note secured hereby, and shall properly adjust any payments which shall have been made under (a) of paragraph 2.
- 4. That he will pay all taxes, assessments, water rates, and other povernmental or municipal charges, lines, or impositions, for which provision has not been made bereinbefore, and in default thereof the Mortgagee may pay the same, and that he will promptly deliver the official receipts therefor to the Mortgagee. If the Mortgager fails to make any payments provided for in this section or one other payments for taxes, assessments, or the like, the Mortgagee may pay the same, and all sums so participally hear interest at the rate set forthin the note secured hereby from the date of such advance and shall be secured by this mortgage.
- 5. That he will keep the premises in as good order and condition as they are now and will not commit to permit any waste thereof, reasonable wear and tear excepted.

That he will keep the improvements now existing or bereafter erected on the mortgaged property insured as may be required from time to time by the Mortgagee against loss by tire and other harards, casualties and contingencies in such amounts and for such periods as may be required by the Mortgagee and will pay promptly, when due, any premiums on such insurance provision for payment of which has not been made hereinhefore.
