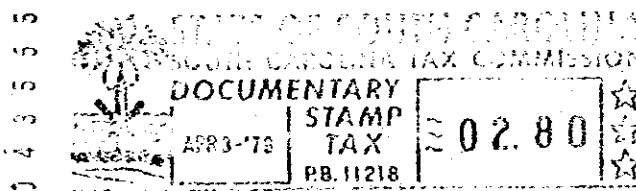

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being known and designated as Lot No. 29 on plat of land of American Bank and Trust Company made by R. E. Dalton, Engineer and recorded in the RMC Office for Greenville County in Plat Book F, Page 44. Reference to said plat being craved for a more particular description thereof.
