Amount advanced \$9,018.09.

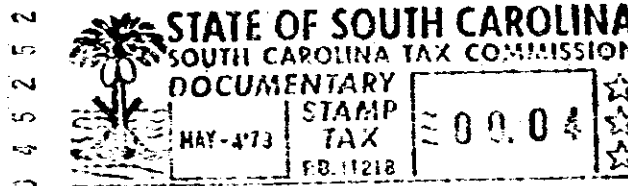
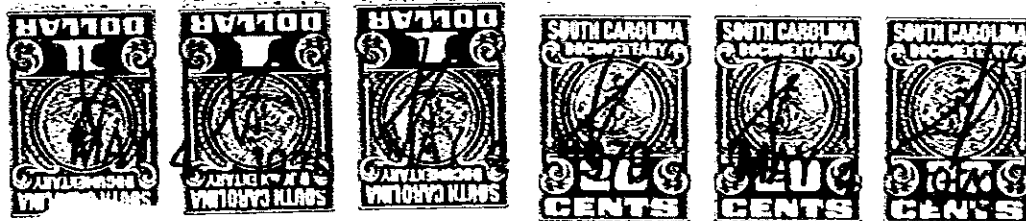
