

MORTGAGE

THIS MORTGAGE is made this 24th day of August 19.79, between the Mortgagor, George E. Fridal and Carolyn D. Fridal
(herein "Borrower"), and the Mortgagee, South Carolina
Federal Savings & Loan Association, a corporation organized and existing under the laws of United States of America, whose address is 1500 Hampton Street, Columbia, South Carolina, (herein "Lender").

To Secure to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville.....,
State of South Carolina:

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the western side of Bent Twig Drive and being known and designated as Lot No. 10 on plat of MAP OF BILTMORE recorded in the RMC Office for Greenville County in Plat Book Y at Page 47, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Bent Twig Drive, joint front corner of Lots 10 and 11 and running thence N.75-14 W. 150 feet to an iron pin; running thence N.14-46 E. 75.0 feet to an iron pin; running thence S.75-14 E. 150 feet to an iron pin on the western side of Bent Twig Drive; running thence with the western side of Bent Twig Drive, S.14-46 W. 75 feet to the point of beginning.

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, casements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
